\* **Centre for Cities Study – January 2009** (The report said that if the recession was mild and the national economy shrunk by 1.1 per cent in 2009, Leeds, Brighton and Bristol would be likely to lose 21,000 jobs (2 per cent) but if the more likely 2.5 per cent contraction takes place, 56,000 jobs (5 per cent) could go across the three cities by 2011.)
